CATEGORIES OF RECIPIENTS OF PERSONAL DATA

Apart from the subjects who are recognised by law the right and interest of access, the personal data collected will not be disseminated and may be disclosed to the Controller's personnel, associations or independent consultants that provide services and activities on behalf of the Controller, in their capacity as external Data Processors, for the fulfilment of legal obligations and any organisational and administrative requirements.

PLACE OF DATA PROCESSING

<u>2M S.r.l.</u> processes the personal data of users in Italy at its main headquarters.

DATA PROCESSING METHODS

The personal data collected will be processed, stored and processed with electronic means and will be stored both in computer files and hardcopy, that are organized in a database.

Specific security measures are taken to prevent any loss of data, illicit or incorrect use and unauthorized access. The processing of personal data by 2M does not involve automated decision-making processes.

DURATION OF THE DATA PROCESSING

The duration of the data processing is determined by law: the personal data concerning the Data Subject will be kept for the time limits indicated in art. 13, subsection 2, of the GDPR 679/2016, for a period of no less than 10 years.

The computer systems and software used to operate the website **WWW.2MFOUNDRY.COM** acquire, during their normal operation, some personal data, the disclosure of which is implicit with the use of Internet communication protocols; This category of data includes IP addresses or domain names of the terminals of Data Subjects who log on to the website, the MAC (Media Access Control) address, the URI (Uniform Resource Identifier) addresses of the requested resources, the time of the request, the method used in sending the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (success, error, etc.) and other parameters relating to the operating system and the IT environment of the Data Subject. the detail identifying the Controller and Processors.

You also have also the right to:

- obtain access, updating, rectification addition of data concerning you;
- request the deletion, transformation into anonymous form or blocking of any data processed in violation of the Law;
- to demand the Data Controller or Processor to limit the purposes or the data processing method.

You also have the right to object, at any time and free of charge, partly or wholly, to

- the processing of the data concerning you for legitimate reasons, even if pertinent to the purpose of data collection;
- the processing of data concerning them in accordance with art. 6, subsection 1, of the GDPR, letter e) (processing is necessary to fulfil a legal obligation to which the Controller is subject).

You have the right to revoke at any time the consent given or object to data processing in the cases provided by article 6, subsection 1, letter a) (expression of consent by the Data Subject) or article 9, subsection 2, letter a) (the Data Subject has given his consent to the processing of his personal data for one or more specific purposes) of the EU Regulations 679/2016, without prejudice to the lawfulness of data processing based on the consent given before the revocation.

You have the right to lodge a complaint with the Privacy Authority, should you deem that data processing infringes the applicable law. This right can be exercised by sending an email request to privacy@2mfoundry.it
